

London SE Social photo competition T&C's

This competition is promoted by England Netball London South East (LSE), located House of Sport, 190 Great Dover Street and part of the All England Netball Association ("England Netball", "we" or "us"), a company limited by guarantee (registered number 01698144) whose registered office is England Netball, SportPark, 3 Oakwood Drive, Loughborough, Leicestershire LE11 3QF.

Any references to "we", "us" or "our" shall be taken as references to England Netball. Any references to "you" or "your" shall be taken as references to any applicant for the competition.

By entering the competition, you are deemed to accept the following terms:

The competition:

1. This competition opens at 00:00:00 BST on **22nd January 2025** and closes at 23:59:59 BST on **16th February 2025**.
2. Entrants to this competition must be residents of the UK, the Channel Islands, or the Isle of Man and have joined England Netball's 2024-2025 membership by 23:59:59 BST on the **22nd January 2025**.
3. This is a competition open to 2024-2025 England Netball members and affiliated to Netball clubs within the London & South East region. Personal membership only. Excludes group membership.
4. Entrants must be aged 13 years or over. Junior members under 16 may enter with permission from either a parent or legal guardian. There are no limitations on the number of times clubs or individuals can enter. Clubs and individuals must be affiliated to the London SE region to be eligible.
5. Employees and officers of England Netball or any companies within the same group or any organisation professionally involved with the competition (or in each case, their close relatives) are not eligible to enter. Clubs and teams of the LSE regional board may enter, but London SE volunteers may not enter individually or take part in any prize individually.
6. If for any reason a technical interruption, fault or site failure occurs when purchasing your membership online, England Netball does not take any responsibility for incomplete purchases and any incomplete purchases will not be considered valid for entry into the competition. England Netball accepts no responsibility for any purchases which are not completed for any reason.

How to enter:

6. To enter the competition the entrant must tag netballlondonse on Instagram or Facebook on their netball team photo. Both the entrant & affiliated club must follow netballlondonse Instagram or Facebook account. You must complete your entry before the closing time and date detailed in paragraphs 1 and 2.
7. If the club does not have a Facebook or Instagram live page, but are affiliated to the London SE region we will still accept entries. All clubs with active Social media accounts must be following netballlondonse on Instagram or Facebook.
8. The entrant must have the permission of all visible persons in the photograph, and the parent/guardians for any players under 16.
9. England Netball shall not be responsible for and shall not have to accept entries which are not submitted before the closing time or are illegible, incomplete, or corrupted. You must have a valid email address and Instagram/Facebook (Meta) account to claim a prize or surprise.

Choosing a Winner:

8. Each entry throughout the time period listed in paragraph 1 & 2 will be eligible. A judging panel on London South East region committee members will select a short list of 20 photos to enter the final judging round by London Pulse squad players on the 22/23rd February 2025. Only one winner will win the Grand Prize.
9. Winners of the competition will be notified by the Instagram or Facebook handle which they entered the competition with, within 14 days after the closing time for the competition. If a winner cannot be contacted or is not available, we reserve the right to select another winner from the valid/correct entries that were received.
10. The winner will be required to confirm acceptance of their prize within 7 days of having been notified. If a winner has not claimed their prize by the date specified, then the winner's prize will be forfeited, and we reserve the right to select another winner from the valid/correct entries that were received. Winners must have a valid email address to claim their prize.
11. For transparency we will generally publish the name of prize winners online and on social media. However, if you are a winner and you object to us doing this or would like us to reduce the amount of information we publish, then please let us know when claiming your prize. In such circumstances, England Netball must still provide the information and winning entry to the Advertising Standards Authority on request.

Each prize and surprise may also be subject to its own terms and conditions, which will be communicated at the time of the draw. We may modify these terms and conditions as necessary, and any changes will be

And that England Netball have the right to use these images in any highlight/winner content shared on Social media and England Netball websites.
31. England Netball may in its absolute discretion change these terms and conditions or extend the competition without notice at any time.
32. England Netball reserves the right to hold void, cancel, suspend, or amend the promotion where it becomes necessary to do so.
33. Where England Netball makes any changes to the prize, no compensation or cash equivalent will be available. England Netball will not be liable for any cancellations or changes to the competition or any prize, or for any loss or damage entrants or accompanying passengers suffer as a result of entering the
